WHAT IS THIS PRODUCT?

► TYPE

This product is an EMTN, a transferable debt instrument.

► OBJECTIVES

The objective of this product is to pay quarterly variable coupons with downward limited annual interest rate, in accordance with the coupon provisions below. This product has a fixed term and will redeem on the Redemption Date.

Payment Dates, will be the Floating Coupon Rate, subject to a minimum and a maximum, fixed on each relevant Floating Coupon Observation Dates

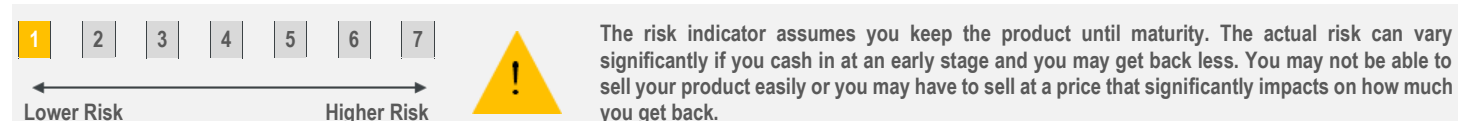
► INTENDED RETAIL INVESTOR

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

► RISK INDICATOR



The summary risk indicator (SRI) is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class.
